Minutes of the Parish Council meeting on Tuesday 10th September 2024

The recent accident and destruction of the phone box was discussed along with reviewing safety measures on the bend to avoid any further accidents.

66/24 Approve Minutes

Resolved: The Parish Council resolved to accept the minutes of the meeting of the 2nd July as a true record of the meeting and were duly signed by the Chair.

67/24 Matters from minutes

Sign for the green – VM advised CE council had replied re costings for siting the Twemlow Village sign and that the costs seemed steep and prohibitive given the precept. **Action** – VM to contact neighbouring parish clerks to enquire what procedure/costs they incurred with their signs.

Planter for the Green – Two large barrel planters to be installed. The barrels are ready for installation at the same time as the sign.

Twemlow Manor Fields – The cutting back of overgrowth has been actioned by Plus Dane. They sprayed the moss, but it needs further attention. CB advised the work had been completed but that the path does need another spray. **Action** – VM to contact Plus Dane again for further treatment to the path.

Damaged noticeboard – Paddy of Men in Sheds has co-ordinated the repair of the board which is now complete. An invoice has been submitted. **Action** – VM to source a combination lock for the notice board.

68/24 Cheshire East Council report

Cllr Chadwick reported as follows;

Library consultation re opening hours is running until the 15th September.

The solar panel scheme is now open via Cheshire East website.

Parking permits for business are not currently transferable.

Cheshire East council are undergoing a transformation plan with a new CEO, changes to the senior leadership team and cost cutting over the next 4 years. Westfield is closing.

Council tax is usually paid by residents, however there are 1% of residents that don't pay. A new scheme is being introduced regarding non-payment.

Tips at Bollington, Poynton & Middlewich are now closed. A mobile refuse collection is operating. Appointments are now needed for tips at the weekend. Fly tipping cleanups are being billed by town councils to Cheshire East council.

A consultation regarding 3 weekly refuse collection is underway.

Contestants in the summer Olympics resident in the Dane Valley ward secured 3 medals.

A 2nd accident at the Twemlow Green bend has destroyed the newly installed phone box. The accident involved a vehicle and a motorcyclist. One of the parties has suffered life changing injuries. The cottage nearest to the phone box is vulnerable to further accidents as are motorists & pedestrians. A resident has advised of further accidents on the bend and will forward details & photographs to the clerk. **Action** – VM to contact the Highways safety officer for an on-site meeting and an urgent review of safety measures at the location.

72/24 Damaged phone box/defibrillator/post box

As a result of the RTA detailed above a claim will need to be made for replacement phone box, defibrillator etc. VM is in contact with the third-party insurers. **Action** – VM to collate estimates for the items needing replacement & submit to the insurers.
